Queries of prospective bidders were answered during the pre-bid meeting. Most of the queries were general in nature and related to technical requirements of NCS. During the meeting NCS informed that EQ Time Series Retrieval Portal (TRP) also need to be implemented with the UDS; therefore, following clauses are added in the RFP.

23. Scope of work

23.7 Design and Develop web based (GUI) online Earthquake (EQ) time series retrieval portal (EQ-TRP);

35. Earthquake-Time series Retrieval Portal (EQ-TRP)

35.1 TRP should have controlled access; i.e. creation of users and their role (such as data from pre-selected stations can be retrieved)

35.2 Bidder has to design and develop a web-based data retrieval system based on following criteria.

Start Time (UTC/IST)

Duration (Min) 3,5,10,15,20,30,40,50,60

Stations: (from the group of list or individual) selectable

Falling in the user defined rectangular grid

Falling in the user defined radius(km) from a point lat. Long.

35.3 Data (Time series) are stored in mini-SEED or SEED format in the storage (source of data). NCS will provide the command line tools to retrieve the data from the waveform data archive in mini-SEED or SEED format.
